# **List of Potential Topics for HITAC Annual Report for FY19**

#### To carry over from Annual Report for FY18

- » ONC's Cures Act regulations: Information blocking, certification enhancements including implementation of APIs
- » Trusted Exchange Framework and Common Agreement (TEFCA)
- » Implications of privacy legislation, cybersecurity framework adoption, and concerns beyond scope of HIPAA coverage
- » Measurement ideas from report recommendations, and for usability
- » Patient-Controlled data collection, access, and sharing
- » Reality gap between the perception of what has been certified for a system and what is truly interoperable in the field
- » Research data ecosystem and governance
- » Social determinants of health (SDOH), patient-generated health data, Internet of Things (IoT)

# List of Potential Topics for HITAC Annual Report for FY19 (cont.)

- From HITAC members' comments on Annual Report for FY18
  - » Challenges with incorporating and reconciling data received from various external sources
  - » Cross-state data exchange and privacy considerations Exchange of imaging reports and images
  - » Highlights of data quality initiatives, e.g., Veterans Health Administration
  - » Patient matching and patients' electronic address information
  - » Policy and trust issues for open APIs
  - » Price transparency and patient access to price information

## List of Potential Topics for HITAC Annual Report for FY19 (cont.)

- Suggested by Annual Report Workgroup to date
  - » Consumer access to immunization data
  - » Data segmentation direction and impact
  - » Digiceuticals/digital therapeutics: Apps used as treatment
  - » Integration of prescription drug monitoring programs (PDMPs) with EHRs
  - » Provider burden reduction opportunities
  - » Sociogenomics: Intersection of social determinants of health (SDoH) and genomic data in health care and research
  - » Standardization of provider notes to enable use and sharing while considering liability implications
