Key Points of Discussion

HTI-1 Proposed Rule Task Force Charge

HTI-1 Proposed Rule Task Force (Task Force) Co-Chairs, Steven Eichner and Steven Lane, welcomed attendees. Hung Luu, Group 3 Task Force Lead, reviewed the meeting agenda and recapped the charge detailed in the [June 8 meeting presentation materials](#).

Update and Revise Draft Recommendations

Hung Luu walked through the Proposed Rule Draft Recommendations document. The Task Force reviewed each recommendation.

Discussion:

- Hung Luu reviewed Recommendations 1 and 2 in Row 2.
 - The Task Force approved of the recommendations.
- Hung reviewed Recommendation 3 in Row 2.
 - The Task Force approved the recommendation.
- Hung reviewed Recommendation 4 in Row 2.
 - The Task Force approved the recommendation.
- Hung reviewed Recommendation 5 in Row 2.
 - Steven Lane asked if Recommendations 4 and 5 could be combined since they touch on the same issue.
 - Hans Buitendijk agreed they could be combined.
 - The Task Force approved.
- Hung reviewed Recommendation 6 in Row 2.
 - The Task Force approved the recommendation.
- Hung reviewed Recommendation 7 in Row 2.
 - The Task Force approved the recommendation.
- Hung reviewed Recommendation 8 in Row 2.
 - The Task Force approved the recommendation.
- Hung reviewed Recommendation 9 in Row 2.
 - Fil Southerland noted he added a comment in the document. He suggested amending the recommendation to indicate that not all certification criteria may be applicable to specialty



- electronic health record (EHR) systems.
 - The Task Force approved the recommendation.
- Hung reviewed Recommendation 1 in Row 3.
 - Hannah said there is misunderstanding throughout the industry that once a new United States Core Data for Interoperability (USCDI) version is published, the exchange of those new data elements is required in every situation. It would be helpful to indicate some of the data elements are pending some other pieces of the rule in the recommendation. She suggested amending the language to include flexibility with USCDI versions.
 - Hans said it would be helpful to have clarity on expectations when new USCDI versions are released. He agreed with Hannah's comment.
 - Deven McGraw said she does agree with Hannah and Hans' sentiment but is not sure it fits in the recommendation.
 - The Task Force approved a recommendation crafted by Hannah pertaining to the need for industry education and clarification that exchange of USCDI data elements are not required in all circumstances, especially where deemed sensitive.
- Hung reviewed Recommendation 1 in Row 5. Row 4 was completed at the June 1 Task Force meeting.
 - The Task Force approved the recommendation.
- Hung reviewed all Recommendations in Row 7.
 - The Task Force agreed on the recommendations.
- Hung reviewed Recommendation 1 in Row 8.
 - The Task Force agreed on the recommendation.
- Hung reviewed Recommendation 2 in Row 8.
 - The Task Force agreed on the recommendation.
- Hung reviewed Recommendation 3 in Row 8.
 - The Task Force agreed on the recommendation.
- Hung reviewed Recommendation 4 in Row 8.
 - The Task Force agreed on the recommendation.
- Hung reviewed Recommendation 5 in Row 8.
 - The Task Force agreed on the recommendation.
- Hung reviewed Recommendation 1 in Row 9.
 - Steven Lane asked if prior authorization could be added to the list of examples in the recommendation.
 - Hung said yes.
 - The Task Force agreed on the recommendation.
- Hung reviewed Recommendation 1 in Row 10.
 - The Task Force agreed on the recommendation.
- Hung reviewed Recommendation 1 in Row 11.
 - Hans tweaked the language to include that "this single approach to certification would not be beneficial, as using different Fast Healthcare Interoperability Resources (FHIR)-based queries for appointment slots are valid alternatives."
 - The Task Force agreed on the recommendation.
- Hung reviewed Recommendation 1 in Row 12.
 - The Task Force agreed on the recommendation.
- Steven Eichner asked to clarify the recommendation on page 5 in the HTI-1 Proposed Rule Task Force Recommendations Report. Previously, certification has meant the entire system needs to be compliant. This creates a challenge for health IT that does not meet all certification requirements. There should be consistency across ONC and Centers for Medicare and Medicaid Services (CMS) certification requirements for health IT.
 - Fil agreed. Some health IT could be excluded from certification because CMS is looking at ONC's certification requirements. He suggested adding an example of nonpublic health



- o agencies, such as community-based organizations, to the recommendation.
- o The Task Force agreed on the updates to the recommendation on page 5 in the Recommendations Report.

Mark Savage: The reference to FASH Shared Care Planning Use Case looks good to me.

Julie Maas: QRS in line 2 should probably be just QR

Deven McGraw: 🙌

Deven McGraw: I missed yesterday - but planned to go back to the Group 2 work prior to tomorrow's meeting

Deven McGraw: Best to use the spreadsheet still or go to the recommendations doc?

Fil Southerland: Use cases that may benefit from modular ONC certification vs. CMS' CEHRT definition include Home and Community-Based Services (HCBS), specialty and non-EHRs, and public health.

Julie Maas: Perhaps modify the final sentence to instead be something like: "Since Health IT certification helps a vendor signal conformance to standards, the health care community would benefit from availability of more fine-grained certification options, when possible, particularly for interoperability-related criteria, to best support interoperability throughout the industry."

Julie Maas: I'm not the Julie that's on your team sorry :)
